- 1. Chief Hail discussed fire season and stated a strike team is still out on a fire. He also briefly addressed the dozer rollover in San Luis. He stated that two of our dozer operators are now helping with the recovery.
- 2. Chief Hail spoke about the progress of Station 72 and some of the issues they have encountered but they are still on track.
- 3. DC Wittwer gave an update on the HVAC unit project for the facilities. He stated they have replaced ten HVAC units within the last 12 months. He mentioned he plans to do two more when the weather cools down. DC Wittwer stated two HVAC units at the training center were recently replaced.
- 4. DC Wittwer stated they are trying to accomplish the Station 87 asphalt project in this fiscal year.
- 5. DC Wittwer gave an update on the fleet. He mentioned with brush engines and staff going out of county, there have been a lot of repairs. DC Wittwer stated the reserves are coming up on 19 years and we need to go over our mobile equipment plan with the Board of Directors.

- 7. AC Michaels stated Battalion Chief Juan Navarro is in the PIO shop and is working closely with him to tighten up processes and take on the ABH. He also mentioned that Battalion Chief Navarro will be working on the Standards of Coverage as well.
- 8. AC Michaels stated the Final Budget will be presented at the next meeting.
- 9. AC Michaels gave an update on the hiring of Communication Operators for the Emergency Command Center.
