Subject: Resolution 2020-05, Volunteer Firefighter Assistance Grant (VFA)

BOARD OF DIRECTOR'S BRIEFING PAPER

ISSUE:

The District has been approved for the VFA grant for Fiscal Year 20/21. To execute the VFA Agreement the Board must adopt a resolution authorizing the District President to execute the Agreement between the District and the State of California, Department of Forestry and Fire Protection (CAL FIRE).

BACKGROUND:

The District has received the grant in the past and used the funds to purchase Personal Protective Equipment (PPE). The current year's budget included these grant funds to purchase PPE.

DISCUSSION:

This grant is a 50% reimbursement grant. The total of the grant is approximately \$38,137.97. Total reimbursement back to the District will be 50% of what was spent or approximately \$19,068.99. District staff plan to purchase structural PPE with this grant. Resolution # 2020-05 is authorizing the District President to execute the VFA Grant Agreement.

ALTERNATIVES:

1. The District could decide to not accept the grant.

IMPACTS *(Consider potential consequences related to each of the following areas of concern for proposed alternatives):*

- Fiscal – There is no impact to the budget since the District had planned on an additional \$20,000 in safety gear expenses. The District would be reimbursed up to 50% of what is actually spent or approximately \$19,068.99.
- Operational – The PPE is needed to maintain serviceable PPE for operational personnel.
- Legal – No known impact.
- Labor – No known impact
